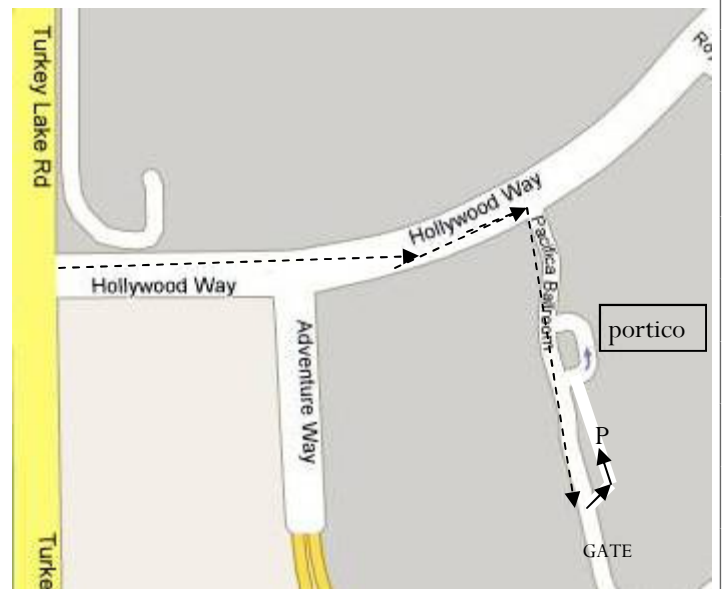
Entrée: Herb Grilled **Chicken** Breast with Teriyaki Sauce, Served with Emeril's Vegetable Fried Rice **OR**

POPPY CHICKEN

Crust:

- 2 T poppy seeds
- 20+ Ritz crackers, smashed
- 1/4 C butter, melted
- Mix, Press 2/3 of it on bottom of 8" x 8" pan

Filling:

- 3 cups of cooked chicken, cut in bite size pieces
- 1/2 pint sour cream
- 1 can soup (cream of chicken or celery)
- Stir together. Spread on top of crust.
- Sprinkle last third of cracker mixture on top.
- Bake 30 min at 350°.
